Following IN decision to set up a contract No 184 to 24.01.2013 in observance of art. 2 of the Public Contract Code of Legislative Decree No 163 of April 12, 2006, and subsequent amendments, in order to select the companies that will be invited as regulated in art. 125 paragraph II, of Legislative Decree No 163 of April 12, 2006, we publish this notice.

Object of the contract:

Supply of an "Individually Ventilated Caging" (IVC) system for rats.

Maximum amount estimated:

Euro 12.000.00 (VAT not included)

Description of the required task:

"Individually Ventilated Caging" (IVC) system, made by:

- 20-25 transparent, plastic, autoclavable cages capable to house 3-4 adult rats/cage;
- 2 external bottles per cage: capacity of each bottle: 250-1000 ml;
- Air Handling Unit, with (a) positive and negative pressure mode and (b) automatic constant flow rate and filter load compensation;
- EPA filters.

- Safety for animals and workers;
- Handiness and easiness-to-use;
- Capability to be expanded to additional racks;
- Noiselessness and power consumption;
